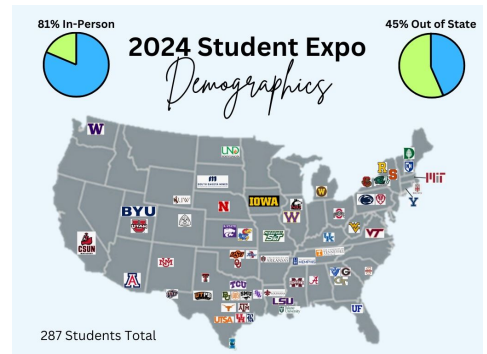


Recruiter and Sponsor Information

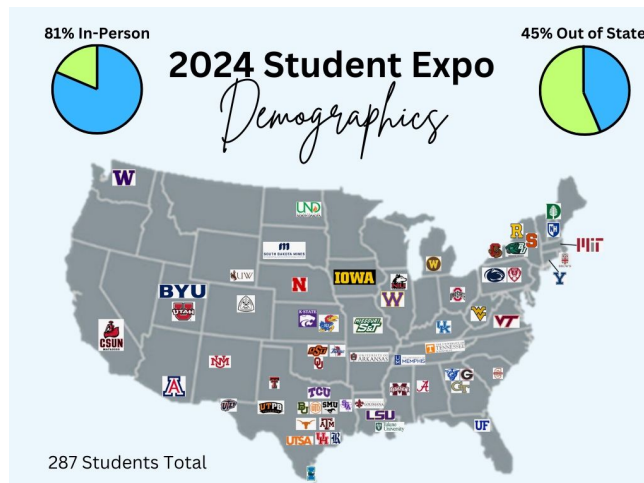

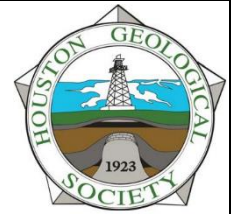

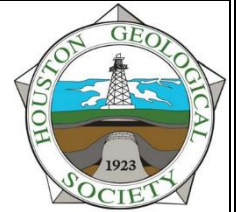

HGS Student Expo Exhibition and Sponsorship Agreement



Terms and Conditions

1. The undersigned (“Organization”) hereby submit the signed agreement (“Agreement”) for exhibition and sponsorship at the HGS Student Expo (“the Event”), to be held, September 15-16, 2025.
2. This agreement shall be binding upon its acceptance as set forth above.
3. All amounts are in U.S. Dollars.
4. Packages are non-refundable and non-transferable.
5. Package monies are to be paid to the Houston Geological Society (HGS) and may be deductible as ordinary and necessary business expenses. They are not deductible as contributions or gifts for U.S. federal income tax purposes.
6. The organization agrees to pay 100% of the total commitment upon signature of agreement. Fulfillment cannot be guaranteed unless package is fully paid.
7. Organizations are required to submit an approved company logo in JPEG, GIF, or TIFF format with this signed agreement.
8. The HGS Student Expo Committee will be ultimately responsible for fulfillment and all expenditures for packages therefore it is required that sponsor initial and date Item #9.
9. The sponsor shall defend, indemnify, and hold the HGS Student Expo and the Houston Geological Society (HGS) harmless from all liability, costs, and damages relating to acts and omissions of organization and its employee’s, agents, and contractors associated with the event. _____ [Initials required.]
10. If for any reason the event is not held, the HGS Student Expo and the Houston Geological Society (HGS) may terminate this agreement prior to the event start date and provide written notice to the organization.
11. This agreement contains the complete agreement of the parties, and all prior agreements, whether verbal or written will be null and void.
